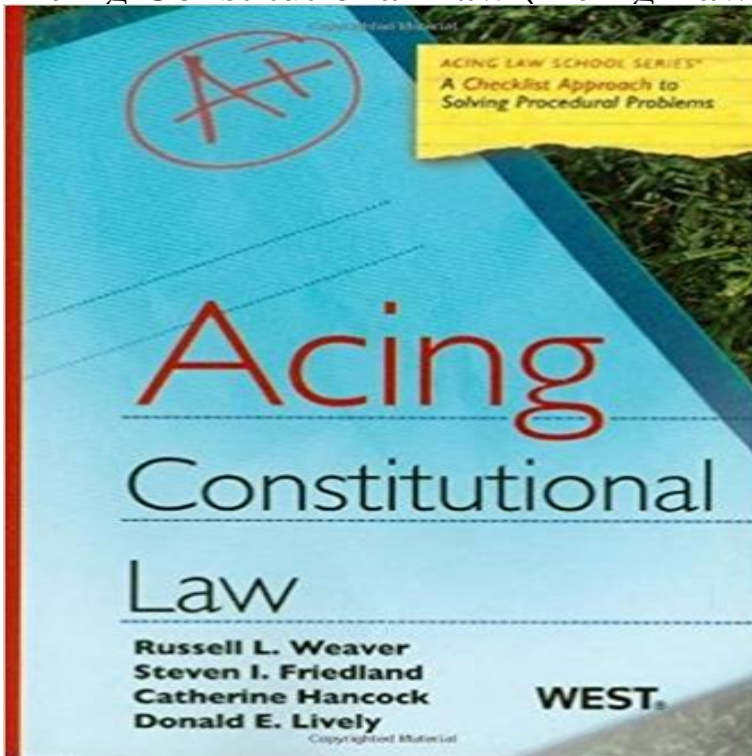


Acing Constitutional Law (Acing Law School) (Acing Series)
