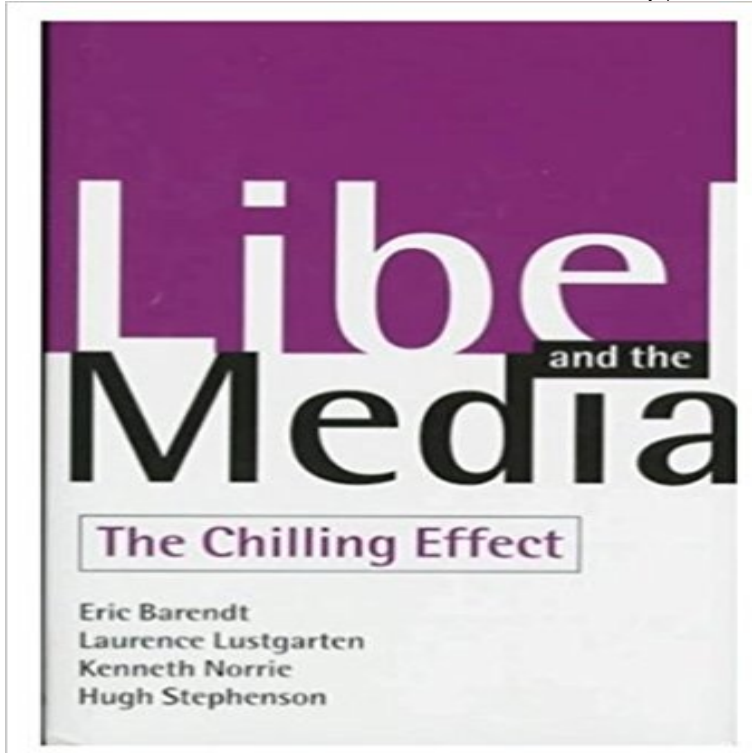


## Libel and the Media: The Chilling Effect
