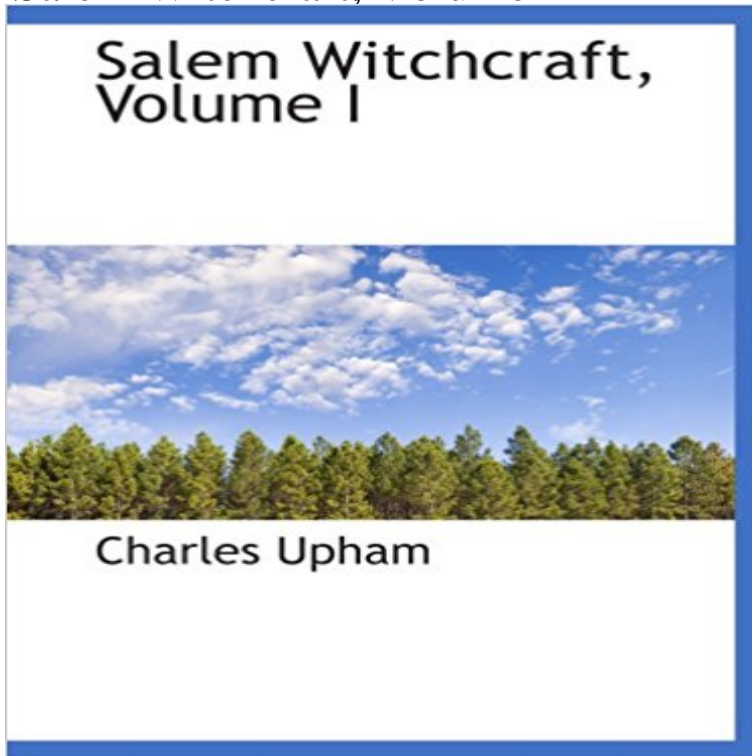


Salem Witchcraft, Volume I
