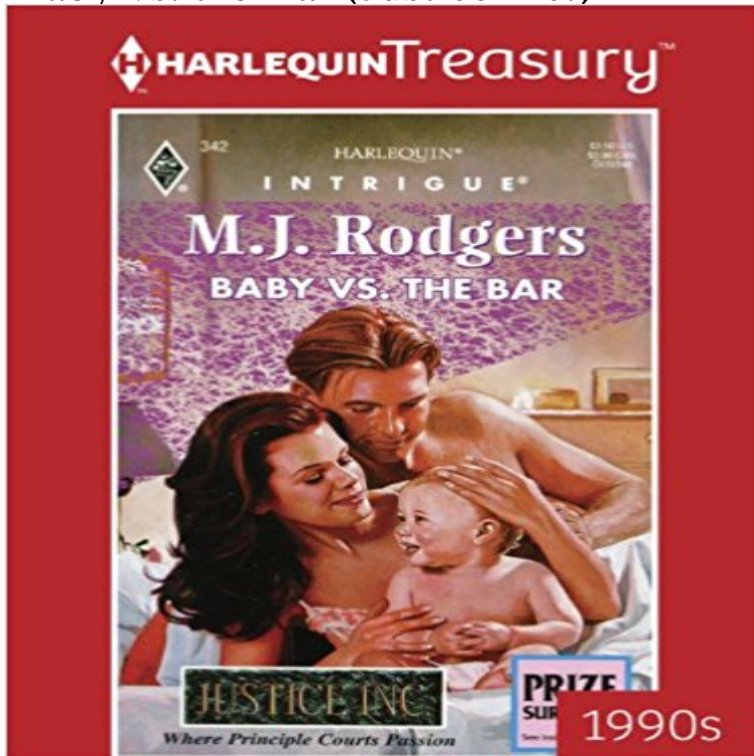


## Baby vs. the Bar (Justice Inc.)
