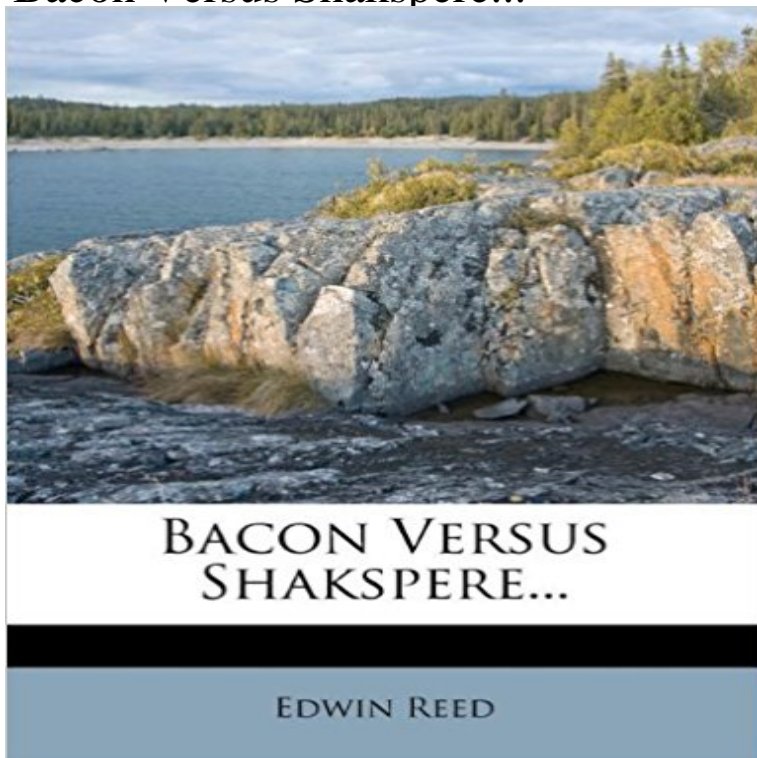


Bacon Versus Shakspere...
